## After School Martial Arts Program Rules and Policies

1. Ray's After School Program hours of operation are from 2:00 - 5:30 P.M.
2. All students must be picked up by 5:30 P.M.
3. A \$5.00 late fee will be charged per child picked up after 5:46 P.M. with an additional \$5.00 per every 15 minutes there after.
4. There will be a \$15.00 charge on all returned checks and declined credit cards.
5. Parents must sign out their child(ren) when they are picked up.
6. Only those persons listed on the Emergency contact list will be allowed to pick up the child(ren) unless the parent or Legal guardian makes a written or verbal request, in person, to the program director. That person must present a valid identification before we will dismiss the child to him/her. There are no exceptions to this rule!
7. Children are encouraged to bring their own snacks or they may purchase them from the center.
8. Children attending Ray's After School Program will be receiving one hour of Tae Kwon Do class two to three times a week and that price is included in their weekly tuition.
9. It is the parent's (legal guardian's) responsibility to notify Ray's Tae Kwon Do Center if the child (ren) does not attend school that day or is going on vacation. This is extremely important so we know they were not in school and therefore will not be attending the program and do not need to be picked up. There will be a \$10 finders fee if we are not properly notified prior to 1:00 pm. 10. It is extremely important that the parents (legal guardian) keep us informed as to how they are doing in school. An open line of communication between school teachers, parents, child(ren) and Ray's After School Program directors are critical so that we can best help your child(ren).
11. All students must wear a clean Taekwondo uniform. Uniforms are to be brought in on Mondays and must go home at the end of the week. Children will not be allowed to participate in Taekwondo class or activities if they do not have the proper uniform. School t-shirt will be permitted on Fridays or on special days.
12. During homework time ALL students must do work. If they are finished their homework they can read or additional work will be provided for them.
13. During Taekwondo class the Dojang (school) rules apply. (see Taekwondo class rules)
14. A two week notice must be given in writing if you plan on removing your child from the program.
15. To ensure the safety of our students, all book bags must fit securely under the seat when traveling in the van during after school pick up. Absolutely no ZUCA'S will be permitted.
16. Ray's Tae Kwon Do Center is not responsible for any personal items left anywhere on the premises including but not limited to dressing rooms, front counter, and dojang.

## Taekwondo Class Rules

1. Bow to the flags upon entering or leaving the dojang (work out area).
2. Always call the instructor "Sabunim" or "Sir".
3. Always answer "sir" loudly when being addressed by the instructor.
4. NO going in and out of the dojang (matted area). Once you enter do not leave until you are finished working out.
5. NO going to the bathroom or drinking water during class time unless the instructor gives permission to do so.
6. NO food, gum, or drinks allowed in the dojang.
7. Jewelry is not allowed to be worn when doing class.
8. Respect those of higher belts.
9. Students must attend classes regularly.
10. Students must be picked up immediately after class is over.
11. When waiting for class to start or waiting to be picked up the students must sit and wait quietly. NO TALKING, PLAYING OR FOOLING AROUND WILL BE TOLERATED before, after or while class is in session.
12. Only practice the techniques, which are being taught by the instructor.
13. Obey your parents!
14. Be loyal to your Master or Sabunim.
15. Always wear a clean uniform. Uniforms are to be brought to the school on Mondays and will go home at the end of the week. Children will not be allowed to participate in Taekwondo class if they do not have the proper uniform
16. Scan your attendance card / key tag / sign in every day when you attend class.
17. All payments must be kept up to date and in a timely manner every depending on your payment schedule.
18. No shoes allowed on the mats.
