



Reserving a campsite in PerfectMind/Xplor Recreation



Login to PerfectMind/Xplor Recreation.
Once logged in, choose **Facility Rentals** at the top of the screen.
Then choose **Chickahominy Riverfront Park Camping**.



You can use the search features on the left hand side of the screen to look by specific campsite numbers, dates or amenities.
Alternatively, you can choose by groupings of **Basic**, **Electric**, **Full Hookup** and/or **Water & Electric** category sites.
